Following up on our call of earlier today I wanted to provide clarity on three points you had asked about:

1. Use of Proceeds: Our intention would be to devote \$100 million of the \$200 million of proceeds from our convertible debenture toward a cash payment to Vimpelcom on closing
2. Due Diligence Process: We had outlined a period of 90 days to complete due diligence and documentation. I think we can complete our business due diligence in a period of 45 days (commencing May 1st) at which point we would provide a sign off that there are no material deficiencies and we would have a firm decision to proceed subject to completion of documentation.
3. Liquidity: We would intend to outline a path for Vimpelcom to monetize its \$100 million in take-back equity within the foreseeable future – one path would be the provision of appropriate registration rights upon a public listing of Wind which we believe could be accomplished in the near future post completion of this transaction.
