

Bruce has been involved in a number of community service efforts, including serving as a Trustee and Board Member of the McMichael Canadian Art Collection from 2002-2005, and as a Trustee and Board Member of the Forum for Young Canadians in 2004-2005.

He is currently a member of the Board of Directors of the Public Policy Forum and a member of the Board of Governors of Laurentian University. Bruce was awarded the Queen's Diamond Jubilee Medal in 2012.


